About Our Policy Priorities:

As part of our organization's ongoing community organizing efforts and commitment to authentic community engagement, our team conducted a two-year listening campaign, engaging +8,500 DPS families, educators, alumni, and community members and culminating in the identification of the issues outlined below. After conducting an extensive listening campaign, Denver Families began work with community members to (1) define our policy agenda, (2) prioritize opportunities for collective action, (3) identify policymakers who will champion the work, and (4) work with those champions to demand the change the public seeks. This work is led by DPS families, educators, alumni, and community members and supported by our team.

Throughout this questionnaire, you will be asked to respond to a series of questions related to your stances on the community's top policy issues - from supporting better academics, increasing safety in our schools, providing access to mental health resources, and more - and how engagement with the community shapes how you lead.
